Remark 2: The prerequisites course is "research methods". students are required to take 3 credit of this subject during their master program and the score has to be higher than 70. Students of the program should complete the subject before graduation and this subject does not count in required credit.

Remark 3: Students who take courses of other department, ratified by the dean, may apply for credit exemption as elective course.

備註 4: 學生須依本校「研究生學術倫理教育實施要點」規定, 完成學術倫理教育相關課程達 6 小時以上, 始得申請論文學位考試

Remark 4: Students that are enrolled in the doctoral programs must complete the academic research ethics education course. each student that enrolls in this course must obtain at least a passing grade for the course's test. The students that have not completed this course are not allowed to apply for their degree examination.

Remark 5: Subject to preapproval by this program, students may take courses offered by other departments. Up to 6 credits may be recognized.
