備註1. 最低畢業學分數：39學分(不含碩士論文6學分)，其中必修12學分、選修27學分。三個模組課程均需選修(至少3學分)，至少修一門全英語授課課程。
 Remark 1: Minimum graduation credits: 39 credits (excluding 6 credits for the master's thesis), with 12 credits required and 27 credits elective. All three module courses must be selected (at least 3 credits each). At least complete one course taught entirely in English must be completed.
 備註2. 先修基礎科目為經濟學以及統計學二學科。應於大學部以上先修基礎科目各至少修滿3學分，且每一科目平均分數應達70分以上，若未修滿3學分，或成績未達70分，須於畢業前補足，始得畢業。本所研究生應於畢業前完成先修基礎科目，先修基礎科目不計入畢業學分。
 Remark 2: Prerequisite basic subjects include Economics and Statistics. Students must complete a minimum of 4 credits for each basic subject at the undergraduate level, with an average score of 70 or above. If not completed with 4 credits or the score is below 70, it must be completed before graduation. Prerequisite basic subjects are not counted

Remark 4: For credits earned outside the department, a maximum of 6 credits are recognized towards the department's graduation credits.
