備註5：「財金專業選修—微學分」以本系所認定之講座演講、參訪、遠距教學、實作研習營、工作坊或相關課外活動為主。累積20小時為1學分，至多2學分。學生須於課程前報名登記，須繳交①報告(內容含課程重點整理200字、心得感想400字及課堂照片乙張)②認證表給該講座之指導老師審閱簽章。請自行保管以上①②資料至滿時數再一併申請抵免學分，未妥善保管任何資料者，敬請自行負責。

Remark 5: The learning forms of the Micro Credit courses can be lectures, institution visits, distance learning, training camps, and workshops and should be approved by the department in advance. 20 hours learning is one credit. Maximum of 2 credits could be counted toward total credits required for graduation.

Remark 6: Students are allowed to take finance practice in any semesters.

Remark 9: Elective credits taken from the Department of Finance (Four-Tear Program) are recognized as elective credits for graduation for students admitted in the current academic year.
