## 壹、申請資格及相關規定

### I. Qualifications and Related Regulations for Application

#### 一、申請資格

#### Applicant Eligibility

(一)符合下列各項條件，始具備外國學生申請入學基本資格：

**Applicants have to fit all of the following conditions to be entitled to apply as foreign students.**

1. 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。

The applicants should hold a foreign nationality without having held R.O.C. nationality. They are not allowed to have the Overseas Chinese student status when they apply for admission.

2. 具外國國籍並符合下列規定，且最近連續居留海外六年以上者。(計算至2021年8月1日)。

If the applicants hold a foreign nationality, fit all of the following conditions and have stayed overseas for six consecutive years (up to August 1, 2021), they are entitled to apply for admission according to the Act.

(1)申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

If the applicants also have R. O. C. nationality when they apply for admission, they shouldn't have registered a permanent residence in Taiwan before.

(2)申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

If the applicants had held R. O. C. nationality before application and they don't have it any more when they apply for admission, they have to be deprived of the R.O.C nationality for at least 8 years since the date approved by the Ministry of the Interior.

(3)前二款均未曾以僑生身分在臺就學，且未於當學年度經海外聯合招生委員會分發。

For the above two clauses, students have not studied in Taiwan previously with the overseas student status or have not accepted assignment from the Overseas Joint Recruitment Committee for the academic year of application.

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。

According to the Agreement on Educational Cooperation, a foreign national selected by a foreign government, organization, or school, is not subject to the limitations as prescribed in the preceding two paragraphs (however, the individual will still need to obtain approval from relevant Taiwan government agencies). Please note: this is applicable only to applicants who have never been registered as part of a household in Taiwan.

3.具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請於香港、澳門或海外連續居留滿六年以上者。

An applicant holding foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macau, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided in Hong Kong, Macau, or another foreign country (overseas) for no less than 6 years is qualified to apply for admission under these regulations.

4.曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

An applicant who is a former citizen of Mainland China, currently holds a foreign nationality, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided overseas for no less than 6 years is qualified to apply for admission under regulations.

第2、4項所稱在海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留時間不超過120日。

The term “overseas” as prescribed in Paragraph 2 and 4 is limited to countries or regions other than Mainland China, Hong Kong and Macau. The phrase “continuously reside overseas” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year.

但符合以下情形之一且具相關證明文件者，不在此限；其國內停留期間，不併入海外居留期間計算：

The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supportive proof:

a.就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education;

b.就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿兩年。

Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry, and to which the total length of stay is less than 2 years;

c.交換學生，其交換期間合計未滿2年。

Exchange students, whose length of total exchange is less than 2 years;

d.經中央目的事業主管機關許可來臺實習，實習期間合計未滿2年。

An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

(二)欲申請就讀學士班者，須未曾在我國以外國學生身分申請並完成高中學校學程。

Applicants who graduated from a junior high school in ROC while registered as a foreign student may not apply to a bachelor degree program.

(三)未曾遭入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者。

International students who withdraw from any university/college after admission due to behavior issues, poor academic performance or a conviction under the Criminal Code may not thereafter apply again.

(四)須未曾因違反本校校規情節重大而遭本校註銷選讀資格者。

Applicants who have been previously disqualified from participating in NTUB courses as a result of any violation of university regulations are ineligible to apply.

(五)須符合招生簡章各系所個別要求之申請條件。

Applicants must meet all of the departmental requirements respectively.

(六)修讀各級學位之入學資格：

**Requirements to apply for each program of study:**

1.外國學生具高中畢業資格者，得申請入學本校四年制學士學位班；具專科畢業資格者具學士學位者，得申請入學本校二年制學士學位；具學士學位者，得申請入學本校碩士班。

International students with a high school diploma are eligible to apply for the four-year bachelor's program; students with an associate degree are eligible to apply for the two-year bachelor's program; students with a bachelor's degree are eligible to apply for the master's program at NTUB.

2.具有與我國學制相當之同等學力資格者。

Applicants with qualifications equal to our academic degree system can apply for admission.

(A notarized copy of the translation in Chinese or English is necessary if the original diploma is not written in Chinese or English.)

##### 1. 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

Academic credentials earned at overseas Taiwanese schools of Taiwanese schools in Mainland China shall be regarded as the same as those at domestic schools with equivalent levels.

##### 2. 前二目以外之國外地區學歷，應依大學辦理國外學歷採認辦法規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

Academic credentials referred to in the preceding two items shall be subject to the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education. However, academic credentials earned from schools or branches established in Mainland China by foreign institutions shall require public notarization in Mainland China and be verified by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan.

Transcripts must show grades for every semester for study in which you were enrolled at that institution.
